### **Secretary's Report:**

### **Medical Director:**

Springfield Hospital ER is asking all transporting services not to give patient Name and DOB in routine patches. This could be considered a violation of HIPPA and is not critical to initial patient triage. It would be acceptable to give them in a life threatening emergency.

### **Training:**

\*Input is requested for dates to hold a refresher course.

\*No State IC course is scheduled, but there may be a system in place for certified instructors from other professions to get reciprocity.

\*There is a need for Intermediate Transition Course.

### **Old Business:**

\*H1N1 - Springfield Hospital is not able to offer site clinics but they are able to vaccinate at the Hospital. Contact Becky Howe M-TH to schedule an appointment.

Nasal Mist is recommended for ages 2-49, Injection for 50+

There is a State EMS waiver for I'03 and Paramedics to administer vaccinations at Flu Clinics, application and information online.

\*Computer Documentation - Online January 2010? at selected "test sites", All reporting by January 2011.

\*District 11 has purchased three (3) Zoll AED Trainers. District 11 now qualifies for a 20% discount on Zoll products.
